125th Inaugural Ejezie Stresses Importance Of **Geotechnical Engineers In Building Construction**

equel to the alarming increase in the number of collapsed buildings in the country, a Professor of Civil and Geological Engineering in the University, Samuel Ejezie, has stressed the need for builders to engage the services of qualified Geotechnical Engineers right from design and construction of structures to avert such

impending disasters.

Professor Ejezie made the recommendation while delivering the 125th Inaugural Lecture of the University at the Ebitimi Banigo Auditorium, last Tuesday,

Ejezie, whose Lecture was entitled: Geotechnical Engineering-The Cornerstone of Infrastructure Development in Difficult Grounds Environment, strongly berated the distasteful attitude of assuming that

"nothing will happen" in constructing defective structures in any part of the country.

He called for such attitude to be "jettisoned because prevention of building failure is cheaper than the cost of failure," advising government to directly get involved in fighting quackery in Geotechnical Engineering practice. This, according to him, can be

n the engaging game of Tennis where Novak Jokovic and Serena Williams reign as king and queen, 'forced error' is compelled by the opposing player to extract valuable points that decide who emerges victorious from a grueling contest. The error is considered as 'forced' when a forehand or backhand stroke from a talented player unsettles the opposing player in the heat of action.

The reigning heavyweight boxing champion in town these days is known as Mr. Treasury Single Account (TSA). The fear of almighty TSA is more than the beginning of financial wisdom for Ministries, Departments and Agencies (MDAs) that are currently grueling under its weight these days. With a new sheriff in town, the hedonists who adored profligacy at its most scandalous manifestation in public places have received a technical knockout punch in their most vulnerable spot.

With the TSA, those roadside bandits, who drove against traffic for so long in government treasury departments, are in for very lean times indeed. The new austere tenant in Aso Rock promised to rein in the monster of corruption and the unbridled impunity that fuels it in high and low places. The TSA is a grinding fulfillment of that pledge on the campaign trail. The fly in the ointment is that those who propounded the gospel according to the TSA claim to stand on higher moral ground, while opponents allege that the policy was not well thought through in the corridors of power. Proponents allege that those crying blue murder brought this sad turn of events on themselves by paying lip-service to fiscal prudent over the years. TSA is here to abolish the rentier state and grease the pole to the treasury.

True, there are some positive sides that hold out promises of cushioning the obvious side effects of this monetary control policy designed to empower government to monitor fringe coded accounts that promote sleaze in the public space. Under the emergent dispensation, MDAs are expected to operate verifiable single or multiple accounts with the Central Bank of Nigeria alone to the exclusion of all others. That is the power of monopoly in a capitalist economy that promotes competition. With this emergent monopoly, the Accountant-General of the Federation is expected to have a clear idea of how much money that is in any account, while government agencies can no longer hide idle cash in one account and turn round to borrow money with another account as was the practice. For instance, report by the last House of Representatives disclosed that N9.4 trillion was not remitted by 60-revenue

generating agencies.

Additionally, Internally-Generated Revenue (IGR) can no longer be incubated in seedy 'fixed' accounts or tampered with, which would hopefully leads to efficient revenue administration through centralized government accounts. Commercial banks that previously depended on government cash flow will now have to go into full revenue drive to stay affoat in a contracting economy,

What the proponents of the new policy failed to bear in mind is the self-evident side effects of this wellintentioned move that is already having dislocating impact on MDAs. Universities are worse hit by the hastily conceived policy that compels them to open TSAs without even passing consideration of their peculiar operational structure.

On the deficit side of things, TSA will further make a mockery of the federal structure in an ethnically diverse country by resurrecting the infamous

unitary system that nearly wrecked us under prolonged military rule. What stops the Accountant-General of the Federation from becoming so powerful that he can determine who gets what, at what time and for what purpose? Worse still, the TSA became officially operational on September 15, 2015 without dress rehearsal or preamble, making it a target of trial and error. Who has been trained to operate the new system? How will the CBN account for the jumbo cash mopped up from the MDAs and wont a new layer of sleaze set in at the AG's office to defeat government's good intention?

The Gestapo-style mopping up of about N1.2 trillion from commercial banks is certainly going to impact negatively on the economy and further elongate the employment queue. The list could be longer than what is stated here, but government has a responsibility to minimize the shock occasioned by its sudden TSA policy-especially as it relates to universities, hospitals and security agencies.

Without making exemptions for these critical sectors, the 'dead hand of bureaucracy' is bound to kill them, together with the TSA that was intended to

was how I secured admission into the Department of Gas Engineering," she told our Correspondent. Miss Amadi, who further disclosed her passion for writing and speaking, said she was tinkering with the idea of working out a platform to combine her passion for the arts and Engineering career.

On her Final Year research project, the student disclosed that her work on Produced Water Characterization, Concerns and Efficient Management in Niger Delta, was aimed at proffering solutions to the adverse effects of produced water' on the environment following oil and gas exploration in the region.

"Produced water is a major concern in oil and gas exploration. My research focuses on the amount of water that comes out in the course of drilling oil. Sometimes, the amount of water is more than the amount of oil production," she stated, listing environmental degradation, damage to aquatic animals and soil erosion as some of the dangers which 'produced water' can cause to inhabitants of the region.

"Treating 'produced water' with chemicals,


hyacinth plants and other technological devices are ways to manage its devastating effects on humans and the environment. The 'produced water' can also be re-injected into the reservoir to enable it produce oil and gas for maintenance of pressure," she added.

Miss Amadi expressed optimism that the outcome of the research would help to remediate the degraded Niger Delta environment and also advance the frontiers of knowledge.

of Mechanical Engineering. s a way of engaging young people to build their entrepreneurial and leadership capacities, the

University of Port Harcourt Chapter of an international student organization, Association Internationale des En Sciences Economiques et Commerciales (AIESEC), has ended a 2-day Leadership Summit that attracted industry players and the academia. The Summit which commenced on Thursday, September 16, ended on Friday, September 17, 2015 at the Ebitimi Banigo Auditorium, University Park.

Delivering a paper entitled: "Leadership for the New Nigeria 2025," former Patron of the Association, Professor Mark Anikpo, described leadership as the ability to inspire others to act together to achieve an objective, explaining that "leadership enables one to impose one's ambition on other people through naked force, monetary inducement or ethnocentric blackmail." Professor Anikpo highlighted depression, youth alienation, unemployment, crime, militancy, religious fanaticism, ethno-phobia, among others, as some challenges young people face while aspiring to occupy leadership positions today, stressing that if youths are able to resist such challenges, then they can achieve their goals in life and leave an enduring legacy.

He added that leadership for the future has to be issuebased, rather than the pursuit of narrow ends that do not advance the public good. "Nigerians must have to learn to be honest and be their brothers' keepers. A leadership forum such as the type being promoted by AIESEC is very important because it is one of the core goals that can advance the career choices of the young ones who are in search of direction in a society that has lost its moral compass," Professor Anikpo said.

The retired Sociology guru, who was Director of the defunct Centre for Ethnic and Conflict Studies (CENTECS), lauded AIESEC for dedicating itself to the development of the abundant talents and leadership potentials of young people from around the world. He disclosed that for anyone to get into any leadership position, such a person "must develop charisma, which is the major force that attracts people to you and to successfully apply charismatic qualities, one must be

upright and just in one's public and private life." He lamented that "leadership in Nigeria has been unproductive, self-seeking, insincere, corrupt and parasitic, but for you to do well and be a dependable leader of tomorrow, you must be creative, innovative and sincere," he told the youths, pledging to continue his mentorship initiative for Nigerian youths at every opportunity.

UniPort, US-Based NGO Seal Partnership Deal On Quality Education

The University of Port Harcourt and a United States-based Non-Governmental Organization, 'Caring For Others Incorporated,' located in Atlanta Georgia, have concluded plans to go into a partnership that would facilitate development of teaching infrastructure in the University.

In an exploratory discussion with the Vice-Chancellor, Professor Ndowa Lale in the Committee Room, last Monday, the Director in charge of West Africa, Dr. Christiana Oduguwa, disclosed her organization's willingness to assist the University with the supply of teaching aids and medical equipment, including provision of exchange and linkages opportunities between UniPort and some counterpart universities in the United States.

She expressed hope that the signing of a Memorandum of Understanding (MoU) between the partners would further strengthen the relationship between both institutions. Giving an institutional profile of the group, Dr. Oduguwa noted that the proposed projects in the University would be executed in phases.

In his remarks, a Member of the University Governing Council, Dr. Nelson Olaniyi, who accompanied Dr. Oduguwa on the trip, commended her spirit of philanthropy, noting that his quest to advance the cause of the University prompted him to reach out to the organization which had carried out similar projects in other higher institutions.

"Whatever assistance we can get from individuals and public-spirited bodies would do the University a lot of good, hence the need for us to interface with organizations such as 'Care for others Incorporated.' We are all working towards ensuring notable changes in the University," he added, promising to always put in his best effort to move the University to greater heights.

Responding, the Vice-Chancellor expressed gratitude to 'Caring For Others Incorporated' for keying into the vision of offering to help strengthen the quality of teaching and research in the University through the provision of relevant study aids.

"We are desperately looking for opportunities like the type you are proposing and we are grateful for your stated commitment to assist the University realize its full potentials," Professor Lale stated, stressing the need for more collaborations between the University and similar institutions to explore areas of mutual interest.

"We want to make a change in the quality of graduates that we produce for the job market and we want them to be independent on graduation with requisite skills. achieved by "enacting and enforcing appropriate legislation or amendment of existing ones to make the Engineering regulation body more effective in checkmating quackery," stressing that the move was necessary because human lives were usually at stake when buildings collapsed.

The one-time Dean of the Faculty of Engineering, who said that he had been engaged in 30 years of teaching and research that had enabled him to apply theoretical and practical knowledge in solving Geotechnical problems, highlighted some of his contributions to Geotechnical Engineering to include "modeling the engineering behavior of soils and prediction of soil responses to dynamic loading; solution of soil structure interaction problems resulting from induced ground vibrations, including dynamic load response of humid tropical soil, development of a framework for producing the engineering behavior of humid tropical soils," amongst others.

Professor Ejezie further disclosed that his study also focused on "laterites and problem soils in Southern Nigeria, solution of foundation

engineering problems in parts of the Niger Delta, failure analysis of geotechnical structures and design of mitigation and protection work in various parts of the Niger Delta, as well as Geotechnical Engineering Education and Manpower Development."

He also advised both private and public developers to ask for evidence of license to practice before patronizing anybody who claimed to be a Geotechnical Engineering Consultant as some people claim to be experts in the profession even though they barely have the awareness, advising developers to always insist on having first hand witness of the progress of site specific geotechnical investigation work carried out by a Consultant before accepting any report.

The one-time Head of the Department of Civil and Environmental Engineering also advised government agencies charged with housing and urban development and approval of building plans to liaise with the Council for the Regulation of Engineering in Nigeria (COREN), the Nigerian Society of Engineers (NSE) and the Geotechnical Division of NSE, in particular, to obtain reliable information on registered Engineers in the discipline, adding that extrapolation of results from one site to the other should be avoided as much as possible.

This was because "subsurface materials exhibit a high degree of variability, vertically and laterally and in both space and time." Professor Ejezie, also said that "the critical nature of Geotechnical Engineering calls for dedicated research and development to guarantee improved safety of constructed facilities and also renders the environment habitable," commending the University of Port Harcourt for taking the lead by establishing the Centre for Geotechnical and Coastal Engineering Research. He expressed hope that when fully operational, the Centre would be a Referral Centre of Excellence for all Geotechnical and Coastal Engineering problems in the Niger Delta region.

In his remarks Vice-Chancellor, Professor Ndowa Lale, who described Professor Ejezie as a thoroughbred academic, who stood out on a number of issues, described Geotechnical Engineering as a very critical specialization that should help builders to stabilize structures to minimize incidents of building collapse in the country.

"Most academics mount the rostrum to deliver Inaugural Lectures; but Professor Ejezie came here to tell us what he has done in his many years of research and teaching in the academy." He commended the Inaugural Lecturer for the brilliant Lecture, stressing that Professor Ejezie had given a good account of himself as an 'ordained Geotechnical Engineer.'

Some form of evaluation of capacity to deliver quality service in an academic setting will not be out of place in my opinion. A University must be able to put its best foot forward in order not to face public ridicule on account of a few staffers who are not able to prove their mettle in the line of duty." Lale told the Union leaders.

Describing the Association as relevant stakeholders

working towards the uplift of the University, he disclosed his resolve to improve the quality of life on Campus, including the provision of municipal services that would enhance staff welfare and motivate them to greater efficiency.

In his address, Branch Chairman of SSANU, Bikume Syder, who pledged the Association's support to the University Management, promised that the Union would constructively engage the administration to address issues bothering on staff welfare and the University at large. "We are ready to partner you to bring about the much desired wholesome and prosperous University of Port Harcourt," he assured the Vice-Chancellor.

Some of the issues raised by the Union included

approval of reviewed career structure, implementation of carned allowances and payment of arrears, expansion of housing facility on Campus, proposed promotion examination, security, staff re-orientation, withdrawal of teaching staff from pure administrative schedules, training and development programmes, amongst others.
