Reprieves For CCE, Graduate Progs As Senate Relaxes Stringent Requirements

n a concerted effort aimed at stemming the progressive decline in the subscription to programmes run in the School of Graduate Studies, Institutes, Centres and College of Continuing Education (CCE), Senate of the University has reviewed stringent requirements in line with the dynamics and current realities in the

Presenting an 11-page report at the 454th Senate Meeting held on Wednesday, April 28, 2021, Chairman of the Committee on Revitalisation of School of Graduate Studies, Institutes, Centres and College of Continuing Education Programmes (CORSICCP), Professor Anthony Ibe, disclosed that the Committee was given a seven-point term of reference.


The terms of reference included to: investigate the immediate and remote cause(s) of decline in admission into graduate and CCE programmes, examine the financial standing and structure of the School of Graduate Studies in terms of income and expenditure, ascertain the global best practices and their applicability in the structure, management and running of programmes in the graduate school and CCE, learn from competing universities in Rivers State and Nigeria in general and to make recommendations on how to reposition the affected academic programmes.

Upon presentation and deliberation of the report, Senate approved far-reaching recommendations. On structure of the programme, Senate has abolished the practice of conducting Comprehensive Examination for Graduate programmes. Senate approved the provision for flexibility where students could run courses in modules.

On administration, Senate reemphasised the

The apex academic decision-making body decided that the minimum requirement for admission into the Master's degree programme is now Second Class Lower division against the initial arrangement of 3:00 CGPA, while a minimum of 3.5 on a 5-point scale is required for Doctoral programmes irrespective of the

On plagiarism, Senate agreed that henceforth, plagiarism check would no longer be punitive but correctional measure. On clearance, Senate decided that students should no longer pay for Clearance form, payments for Success Letter and Statement of Result are reduced by 100% as each payment now goes for N5,000. Senate decided that owning Convocation Gown by Doctor of Philosophy degree holders should be ontional with different fees for those who want to keep or return it.

On CCE, Senate decided to maintain the current payment regime. Senate recommended the use of e-learning or blended learning for students on the programmes run in the College of Continuing Education. The august body called on Management to prevail on the Unions to exempt CCE from industrial actions since it is a non-NUC

> On how the heart could say goodbye, the Valedictorian revealed that "the heart gives warnings by way of signs and symptoms when its structures and functions are impaired or

affected by diseases or disorders." Some of the early warning features, according to him, are easy fatigability, cough productive of frothy sputum, swelling of the ankles, swelling of the abdomen, difficulty in breathing on exertion or at rest, chest pain and irregular pulse or heartbeat.

"In the presence of these symptoms and signs, one is advised to see a doctor. The doctor would, in all probability, advise one to see a cardiologist. The doctor/cardiologist would undertake some or all the following in order to understand the nature of the disease," he said. Professor Odia, who served as Provost, College of Health Sciences, listed establishment of the Port Harcourt Medical Journal, Centre for Medical Research and Training (CENMERT), commencement of Dentistry, Nursing and Pharmacy programmes as some of his modest contributions to the growth of the College under his watch.

enate of the University has elected four statutory members to represent it in the Governing Council. Those elected are: Professors Clifford Ofurum, Ngozi Iheanacho, Martin Ifeanacho and Nnenna Frank-Peterside. The four representatives emerged in an election conducted as part of the agenda for the 454th Senate Meeting held on Wednesday, April 28, 2021 at the Senate Chamber inside Senate Building, University Park.

Speaking before the election, Chairman of Senate and Acting Vice Chancellor, Professor Stephen Okodudu, disclosed that nine candidates indicated interest to represent Senate as internal members of Council. Announcing the result of the election, the Chairman of Senate, who was also the Chief Electoral Officer stated that Professors Ofurum garnered 164 votes, Iheanacho polled 151. Ifeanacho had 126, while Frank-Peterside polled 125. Professors Iyeopu Siminialavi scored 109. Chukwudi Onveaso polled 108, while Olufemi Adesope and Victor Inoka got 99 and 10, respectively.

Earlier, Director of Academic Affairs, Dr Agatha Ataga, who represented the Registry in the conduct of the election, stated that a total of 276 Senate members were accredited for the election. She also announced that the rule allowed only statutory members of Senate to be voted for in the elections of internal members of the Governing Council, **Boards and Committees**

Professors Christie Omego and Gabriel Oladipo are to serve on the board of University Demonstration Primary School, while Professors Clara Olele and Prince Asagba are to serve on the board of the University Demonstration Secondary School.
