## Omuokiri Killings

## **Education Minister, NUC Scribe, Condole UNIPORT**

Sekibo, Uchendu Too

inister of Education, Professor Ruqayyatu Rufa'i and Executive Secretary of the National Universities Commission (NUC), Professor Julius Okojie, have both expressed their heart-felt condolences to the University and the bereaved families over the gruesome murder of four students of the University by an irate mob at Omuokiri community in Aluu clan in the wee hours of Friday, 5° October, 2012.

Represented by Professor Adebisi Balogun, who led members of the Inter-Ministerial Committee on Campus Safety to the University on a fact-finding mission, they expressed grief over the incident and described the action as barbaric and dastardly, stating that the Committee decided to embark an on-the-spot assessment of the incident. "When we received news of this ugly development, we decided to undertake an onthe-spot assessment of what happened, and also interact with stakeholders to gather accurate information on the incident. This exercise is very important because we need to make recommendations to the Federal Government, especially as it has to do with accommodation in our universities with a view to convincing government on the need to build more hostel accommodation in the universities", adding By Obinna Nwodim

that the Committee would also initiate a stakeholders' forum to share ideas on how to solve the problem of insecurity in the nation's universities.

Professor Balogun, who was former Vice-Chancellor of Federal University of Technology, Akure, disclosed that the Commission would prepare a bill on cultism that would include input from stakeholders before it would be tabled before the National Assembly for further deliberations.

In his response, Vice-Chancellor, Professor Joseph Ajienka, briefed the Committee on the sequence of events, as well as measures so far taken by authorities of the University to contain the highly combustible

situation. The Vice Chancello r said that the author ities have conta cted familie of the decea student Senator Sekibo

written condolence letters and sent a delegation to commiserate with them over the painful losses, pointing out that everybody in the University was alarmed by what happened. He thanked the Honourable Minister, the Executive Secretary of NUC and the Director of Higher Education for the support given the University during its trying period of grief and anger.

Professor Ajienka told the delegation that the University had enjoyed very excellent relationship with its host communities over the years, stressing that what happened needed to be properly investigated to forestall a reoccurrence of similar incidents in future. "It was a very unfortunate development and we hope that such a horrendous incident would never happen again in any Nigerian University".

He reiterated the need for the Federal Government to address the sensitive issue of land compensation to the host communities that the University was currently facing; pointing out that it posed a grave security risk to the Management of the University. Professor Ajienka disclosed that while the issue of land compensation was not responsible for what happened at Omuokiri community, the frequent disagreements with the University's host communities were capable of threatening peaceful co-existence in the area.

Members of the Committee interacted with the Student Affairs Department, Student Union leaders, as well as the Choba Council of Chiefs and later visited the scene of the killings at Omuokiri community to see things for themselves.

In a related development, the Senator representing Rivers East Senatorial District in the National Assembly, Chief George Sekibo and the Member representing Ikwerre/Emohua Federal Constituency in the House of Representatives, Chief Andrew Uchendu, have separately commiserated with authorities of the University over the sad incident at Omuokiri. Senator Sekibo, who described the incident as very painful, expressed shock that such a barbaric act could happen in 21" Century Nigeria. "As your representative, I want to assure the University

community and the public that the Senate is taking some definite steps to ensure that this unacceptable incident does not happen again in our country.

"I wish to condole with the entire University community and parents of the deceased over the mindless killing of the four students, whose alleged offences were not established before they were murdered in cold blood by a lynch mob. It is barbaric, satanic and I cannot find suitable words to describe such a barbaric act", the Senator said. He lauded the efforts made by authorities of the University to contain the difficult situation, describing the temporary closure of the Institution as a step in the right direction under the circumstance. Senator Sekibo advised community leaders to closely scrutinize the character of people who live within their neighbourhood as a way of nipping such incidents in

Also speaking, Honourable Uchendu, said that the incident was strange and completely not part of the conduct of his constituents, who he said have respect for the sanctity of life, disclosing that the community was willing to cooperate with security agencies to establish the true facts that led to the ugly incident. "The hearts of the entire Aluu community and Ikwerre Ethnic Nationality go out to the parents of the deceased and the University community. The people of Aluu have assured me of their willingness to promptly apprehend and hand over any of their son or daughter that may be implicated in the commission of the heinous crime. We pray God to grant the bereaved families the fortitude to bear the irreparable losses which have diminished all of us in the brotherhood of man", he stated.

Responding. Vice-Chancellor, Professor Joseph Ajienka, who separately briefed the law-makers on the incident, thanked them for their show of solidarity with the University in its moment of grief. He said that "the University community was eagerly waiting for justice to be done so that the perpetrators of such an evil act would be speedily brought to book. The law enforcement agencies must leave no stone unturned in their bid to bring justice to families of the murdered students. We appreciate your concern over what has happened in these trying times", he said.

Honourable Uchendu was accompanied on the visit by the Chairmen of Ikwerre and Emohua Local Government Councils, Messrs Welendu Amadi and Allen Nma, respectively.

## V-C Charges Administrators On New Skills

Declaring open a two-day Global Concepts Management Workshop on "Critical Thinking for Executive Decision Making" last Tuesday at the Council Chambers, University Park, Professor Ajienka, described the theme of the workshop as timely. "Critical thinking or thinking outside the box comes in handy during this era of sustainable development which also entails not only funding, but human resources development and management by a skilled workforce".

The Vice-Chancellor, who remarked that no organization can grow without training and retraining her staff, pointed out that the essence of the training was to keep abreast with new technological developments to enable the University compete favourably with other universities. Pledging Management's commitment to providing more training opportunities locally and internationally, Professor Ajienka advised participants to "put what is learnt into practice. Join the few that work selflessly to put the image of the University right", he charged them, promising to initiate a reward mechanism for diligent staff.

Earlier, Registrar, Mrs Matilda Nnodim, emphasized the role of staff as partners in driving the

vision of the University administration, calling on participants to invest the training received in the upliftment of the University. "Go back to sharpen your skills and lift the image of the university even as it goes through this crises period", Mrs Nnodim pleaded with the participants.

The Registrar, who charged them to be open-minded to gain from the Workshop, said it was a consolidation of the promises made by the Vice-Chancellor on assumption of office. "Let this investment not be in vain", she advised, reiterating the need for them to be at par with their counterparts in other parts of the world.

Facilitator of the Workshop and Resource Person, Mr Segun Ogunkola of Global Concepts Management, Maryland, America, who emphasized the role of critical thinking for executive decisionmakers, told participants that their decision as Senior Administrators can impact negatively or positively on the University. Explaining that their sense of reasoning must never be in doubt, Ogunkola advised them to resist having their decisions beclouded by emotions or personal considerations.

The Workshop which was organized by the Staff Training and Development Unit, Registry Department, had in attendance, Principal Officers of the University, Centre and Institute Directors, Deans of Faculty, including College of Health Sciences, School of Graduate Studies and Registry Directors. It was rounded off with an interactive session and group activities.

elf-styled student activists who hide under the cloak of National Association of Nigerian Students (NANS) to foment trouble and issue threats on the University of Port Harcourt on reinstatement of Dr Andrew Efemini as Acting Head of Department of Philosophy, have been warned against aggravating the already tense situation on Campus, following the killings of four students of the University at Omuokiri community in Aluu Clan.

Concerned students of the University, who issued the warning in an interview with UNIPORT Weekly last Thursday, reiterated their condemnation of the act by the unruly mob which took the law into its hands, condoling families of the slain students for the irreparable losses. They called on their colleagues to allow law enforcement agencies investigate and prosecute the case to its logical end, rather than issuing empty threats against the University and its host communities.

Meanwhile, two weeks after closure of the University following a violent protest that resulted in looting and wanton destruction of property at Omuokiri community in Aluu and its environs, the students also appealed to


## Concerned UNIPORT Students Warn NANS, Appeal For Resumption

Senate of the University to reopen the Institution to enable them conclude their programmes in record time. Warning those who claim to be members of NANS to refrain from threatening to attack the Institution when it resumes to desist from such an evil plan, the students led by a former presidential candidate in the botched Student Union election, Mr All Is Well Eme, said that carrying out such baseless threats would run contrary to NANS' earlier condemnation of lawlessness as witnessed in the Omuokiri killings. The group said that two wrongs cannot make a right in the circumstance.

"For two weeks now, we have been mourning the lynching of four of our colleagues by some inhuman elements in Omuokiri Community in Aluu. We are yet to fully recover from the shock of such barbaric and atavistic act which has traumatized us emotionally and psychologically. We would, therefore, not condone any obnoxious behaviour that would aggravate the sorrowful situation", the students warned, advising NANS, Civil Society groups and political parties which had shifted attention to the University by calling for removal of the Vice-Chancellor, to concentrate on the case which had attracted wide condemnation and now before the Court, rather than diverting attention to other irrelevant issues that tend to diminish the memory of the murdered students.

"Justice for the murdered students and prompt resumption of academic activities should be the primary focus of all genuinely concerned students, the University authorities and the general public, not childish threats

# Only Professionals Should Be Allowed To Teach ~Ogunkunle

s Nigerian teachers joined their counterparts across the globe to mark the 2012 "World Teachers' Day" on October 5, Acting Director, Centre for Teacher Education and In-Service Training, Dr Abiodun Ogunkunle, stressed the need for the professionalization of the teaching profession in Nigeria to ensure that only those licensed to teach are found in classrooms.

Ogunkunle, who made the observation in a chat with UNIPORT Weekly, penultimate Thursday, noted that there were many challenges facing teachers in the country, especially, nonprofessionalization of teaching, regretting By Humphrey Ogu

that despite the existence of the Teachers' Registration Council of Nigeria (TRCN), teaching was yet to be fully professionalized, a situation, she said militated against the desired optimal results from the educational system at all

"The Teachers' Registration Council has not yet registered all teachers practising in the country as members. That alone is a big challenge. We have all sorts of people masquerading as teachers in the educational system. In advanced countries, you need a teachers qualifying status before you will be allowed to teach in any primary, secondary, or even tertiary institution," she pointed out, warning that the free-for-all situation in Nigeria must be reversed for the country to regain her pride of place in the critical sector.

"We need to go beyond giving out certificate of registration; so many people are not even aware that after acquiring such certificates, they still need to be licensed before they can practise. This is because most institutions are not owned by professionals," the Director said, stressing that "until quality assurance measures are put in place to fish out those who do not have the required certificates and licenses from various schools, those currently teaching illegally will not see the need to be licensed before practicing as a precondition for entering the profession." According to the Don, most people look down on their colleagues who opt for degrees in Education, only to resort to teaching on graduation, having failed to secure their preferred jobs. Conceding that there are born teachers, who still needed to follow due process to get to the pinnacle of their career, Ogunkunle decried a situation where teachers continue to depend on what they learnt decades ago, without updating their knowledge in line with the needs of a digital learning environment.

Commending the recent restructuring of the Institute of Education, Ogunkunle said: "there is the Centre for Teacher Training and another one for In-Service Training for creating innovative programmes, providing short term training for teachers to improve their skills, especially in this era of information technology."

Ogunkunle, who described the perception of Nigerian teachers as poor, stressed that their image has to be redeemed, adding that "this could be achieved when stakeholders take a stand for teachers in line with the 2012 theme for World Teachers' Day, which was: "Take a Stand for Teachers". According to her, the theme was timely and a step in the right direction, blaming low-quality graduates on the educational system, which she said, emphasizes materialism at the expense of quality and personal integrity.

World Teachers' Day is celebrated annually on 5th October to highlight the critical role of teachers in providing quality education at all levels for the accelerated development of society.

recounted that the first annual national conference, publication of three volumes of Trends in Educational Studies Journals and the ongoing Conference edition of the Journal in addition to quality teaching and research were part of the milestone achievements of his administration.

The erstwhile Acting Director, who recalled that he closely monitored the affiliation programme of College of Education, Warri, in order to strengthen ties between the two institutions, called on his successor to sustain effort aimed at securing accreditation from the National Universities Commission (NUC) for programmes of the Institute, stating that full implementation of the new restructuring plan of the Institute was ongoing before he left office.

He disclosed that he handed over a number of office furniture, computer systems and vehicles to the new Director, stating that implementation of new Centres and programmes and decision on remuneration for Teaching Practice for the Postgraduate Diploma in Education programme were ongoing matters before his successor, who he described as a seasoned administrator.

# UNIPORT Authorities Condole Slain Students' Families

authorities of the University have condoled with families of the four students who were gruesomely murdered in a mob attack in Omuokiti community, Aluu Clan by an irate mob. The messages were conveyed when an official delegation from the University paid condolence visits to the bereaved families, last Monday.

In an emotion-laden voice, Vice-Chancellor of the University, Professor Joseph Ajienka, told the grieving families that the University was still in great shock over the horrendous incident. In separate condolence messages to the families, Professor Ajienka, who was represented by Deputy Vice-Chancellor (Administration), Professor Ethelbert Nduka, described the incident as unfortunate, stating that the University had been in deep grief over the incident. He prayed God to grant the bereaved families the fortitude to bear the irreparable losses they suffered. He assured them that the University would always stand by them in their quest for speedy justice and emotional support, appealing to law enforcement agencies to intensify efforts aimed at apprehending all those connected to the heinous crime that has dragged the good image of the Institution to the mud and brought great anguish to so many homes. In their separate speeches, the families

In their separate speeches, the families expressed sadness over the incident and called on both government and authorities of tertiary institutions in the country to improve security around their various campuses to avert such incidents in future. They said that their children paid the supreme sacrifice so that critical issues that affect the society—especially young people, would be addressed by those in positions of authority, calling on the government to immortalize the victims for paying the supreme price for the barbarism of the society into which they were born.

The University delegation visited the families of Chidiaka Beringa, Lloyd Toku, Tekena Elkanah and Ugonna Obuzor, all students of the University, who were gruesomely murdered in a mob attack, at Omuokiri, Aluu on Friday, 5° October, 2012.

Other members of the delegation included the Dean of Student Affairs, Professor Henry Bell-Gam, PTDF Chair of Petroleum Engineering, Professor Elijah Iyagba, Director of Community Service Centre, Professor Anthony Ekine, Professor Ben Ndukwu of the Department of Plant Science and Biotechnology, Director, Academic Affairs, Mrs Dorcas Otto, while Interim Students Union President, Mr Maxwell Nyanabo led the students' delegation.

"the position of Head of Department is a position of responsibility that students and junior academics look up to as a role-model", pointing out that "as Acting HoD, Dr Efemini statutorily represents the Vice-Chancellor in the Department and outside the University and whatever he does in that position, I also bear vicarious responsibility as the appointing authority". He added that "since I am not convinced of his method of making inciting statements that further infuriated an already angry mob protesting the mindless murder of students at Omuokiri, community in Aluu Clan, you would agree with me that Dr. Efemini's ill-advised action on that day inflamed an already tense situation that we were battling on all fronts to contain" adding that "under the untenable situation in which Dr. Efemini's action put me, it was better to protect him and myself.

"I have also a responsibility to protect the institutional image of the University that was already dealt a crushing blow by the horrendous incident at Omuokiri. I, therefore, had no other choice but to relieve him of the mantle of responsibility so that he could be free to act according to his freewill" He said that "inciting one violent mob action after another is an inexcusable celebration of criminality and an invitation to chaos and anarchy that cannot be tolerated by any responsible administration. That was why I removed Dr Andrew Efemini as Acting Head of Department of Philosophy in line with the extant rules governing the terms of his appointment to that exalted position in the University".

The Vice-Chancellor stated that "in enlightened societies where subordinates have cause to openly disagree with their superior officers on matters of principle that are anchored on personal convictions or ideological differences, they resign honourably" adding that "one level of leadership or authority does not undermine a higher level of leadership in the pursuit of personal principles or ideological differences, let alone make inciting public statements on a very delicate situation that was capable of engineering a mob action".

The Vice-Chancellor reassured stakeholders of the administration's determination to restore normalcy and initiate confidence-building measures that would create a conducive atmosphere for the return of students to the University's host communities, stating that "we want to be sure that our students and staff who live in the host communities would be guaranteed their safety and harmonious relationship with their landlords, as used to be the case" adding that " in a society that is governed by the rule of law, we all expect that everybody who is directly or remotely connected with the heinous murder of our students will be speedily brought to book to serve as a deterrent to others, who may wish to follow such unacceptable conduct. Nothing but justice will satisfy the bereaved families and the general public that watched the gory lynching of four young men on charges that were yet to be subjected to proper legal scrutiny".

The Vice-Chancellor commended the great care and maturity of the police personnel on duty that day that averted more bloodshed, pointing out that the country and indeed the world would have been more alarmed and infuriated by the resulting violence from careless statements in a highly combustible situation that called for utmost restraint on all sides.

## NZIC Team Proposes Faculty Of Environmental Sciences From Geography Dept

s part of efforts aimed at improving academic standards in Nigerian universities, the National Universities Commission (NUC) Accreditation Team evaluated programmes in the Department of Geography and Environmental Management and the Faculty of Dentistry, penultimate Tuesday.

At an Exit Meeting with the Vice-Chancellor, Professor Joseph Ajienka, Leader of the NUC Team to the Department of Geography and Environmental Management, Professor Augustine Eziachi, recommended the separation of the Department into two distinct Departments to be housed in the Faculty of Environmental Sciences with Estate Management, Quantity Survey and Architecture as additional programmes that could benefit the people of the Niger Delta region.

Disclosing that the recommendation is based on the need to reduce the academic workload of students, who labour to merge the degree with single honours, Professor Eziachi, commended the quality of academic work in the Department, describing the curriculum as adequate. "Your staff and student ratio meet the minimum requirement and your staff mix is quite commendable", he said. The Team Leader, who commended the Department for the quality of facilities and equipment available for training of students, stressed the need for them to improve on the provision of e-books, Journals and computers, while tasking the Department on the need to be Health, Safety and Environment (HSE) conscious at all times through the provision of safety gadgets at strategic locations in the University.

Also speaking, Leader of the Team to the Faculty of Dentistry, Professor Gbemisola Oke, commended the Faculty for its quality of teaching staff, describing them as a team to be proud of. Oke, who stressed the role of quality medical educators to boost the ailing health sector in the country, urged the Faculty to continue to advance the cause of the medical profession, disclosing NUC's endorsement of the programme.

Receiving the team, Vice-Chancellor, Professor Joseph Ajienka, who acknowledged the objective assessment of the academic programmes by the Team, promised that substantial improvements would be made in the recommended areas. He also reaffirmed the commitment of the University Management in ensuring that the medical school would be rated as one of the best in the country.

The Vice-Chancellor lauded the team for suggesting areas of improvement, expressing hope that the University would benefit from the exercise. Professor Ajienka reiterated the University's drive to become an Entrepreneurial University that can capitalize knowledge for the benefit of society.

## **Insecurity And Jungle Justice In Nigeria**

here is an overwhelming feeling of insecurity in our society today which results from fear of criminal activity. It is the civic obligation of government never to allow citizens feel insecure, because insecurity of lives and property is a dangerous feeling. Insecurity is a situation devoid of governmental protection in which a person or group of persons feel helpless and dehumanized by acts that threaten life, including law and order.

The law requires that when a citizen is accused of committing a crime, the alleged criminal act must be proved and punished only through the due process of law. Any act of punishment that does not follow due process is an act of jungle justice, which is the exact definition of 'extra-judicial murder'

or compensatory punishment of tit-for-tat (an eye for an eye). When these helpless citizens react to insecurity by taking the law into their own hands by punishing those they presume to be a threat to their security, jungle justice occurs. No society or group is authorized by law to impose any form of extrajudicial punishment on other citizens without following due process as prescribed by law, which requires

that any form of crime be proved in a court of competent jurisdiction. Such a formal judicial process requires irrefutable evidence that the alleged crime was indeed committed by the accused person or persons. It also

person or persons. It also Iwarimie-Jaja
requires that the act be clearly established to have
been committed with malicious intent—mens rea.
Citizens who suffer from crime that result in death,
bodily harm or threat to property must show
evidence of physical harm—actus reus—to justify
laws that viewice.

The rich can afford to buy personal security, but the poor cannot buy security making the resort to self-help more likely, though not justifiable. Jungle justice is mainly carried out by youths and poor people, who cannot afford to buy protection or go through complicated legal processes that take so much time and resources. Those who resort to self-help may believe that they are protecting themselves from criminal elements in the belief that

government has denied them security. Sometimes, criminally-minded persons among the youths and the upper class hijack the idea of jungle justice or extra-judicial killings to further their personal interests.

Commission of crime which may be followed by jungle justice prevail in Nigeria because the people appear to have lost confidence in the criminal justice system, especially in the ability of the Police to investigate and prosecute crime. A situation where the people take laws into their own hands or where justice is administered without due process is a call to anarchy. The recent mob-lynching of four students of the University of Port Harcourt at Omuokiri in Aluu is a clear example. The Police are

seen as corrupt and accused of sometimes colluding with criminals to perpetrate crime, while also helping them to evade justice. It is generally believed that the Police are slow in their response to distress calls from victims of crime, while the court system is slow in the dispensation of justice.

The government is aware of the situation, but has not responded effectively to the challenge, which appears to predispose some citizens

to jungle justice or self-help as was witnessed at Omuokiri and many other places in Nigeria today.

Insecurity in Nigeria manifests in such serious instances as petty theft, burglary, assassination,

cultism, ritual killings, rape and corruption. Jungle justice is a cause for serious concern because it portrays us as an uncivilized society. The legislature must check this growing trend by promulgating laws that would make aiding and abetting of jungle justice a capital offence. The way forward is to devise new strategies for effectively policing the country. The time has come for Nigeria to experiment with the idea of State Police and Community Policing as an effective safety-valve against jungle justice.
