Blood Transfusion Key To Modern Healthcare ~*Prof Ejele*

Banigo Auditorium, last Thursday, also

called for the creation of a National Blood Service Authority in line with standard recommendation of the World Health Organization and other international blood transfusion agencies.

"What is needed to achieve the objective of blood safety in Nigeria is for government to approve establishment of a National Blood Service Authority, Agency or Commission, with full service and regulatory powers. Legal empowerment and financial support for the Commission will be required and is hereby advocated," he stated, citing the National Action for the Control of Acquired Immune Deficiency Syndrome—AIDS and National Agency for Food and Drug Administration Control (NAFDAC) as examples of successful regulatory bodies that are of immense benefit to the country.

As a measure to save lives of patients who could die due to non-availability of blood, Ejele said: "we implore all of you in this

SGS Public Lecture

We Need Gown And Town Towers ~*Afolabi*

Nigerian Transformational Development Programmes: The Ivory Towers, Where Art Thou? Are there Opportunities to Pick?, the Guest Lecturer, who made a review of some fundamental government policies, stated that lack of commitment by successive governments to implement laudable blueprints contributed to the apparent stagnation of tertiary education in Nigeria.

In what he described as diagnostic analysis to the problem of the Ivory Tower, Professor Afolabi, who traced the origin of leadership to a practice where those in positions of authority are expected "to go forth to die" in course of protecting and defending the common people, said Nigerian leaders must be prepared to give out their best to get it right.

Professor Afolabi advised universities to always engage in peer review to prize excellence from scholars, review curricula to be responsive to current realities, as well as give preference to applied research which could translate into solving societal problems, rather than focusing strictly on academics, adding that carryingcapacity and quality of students should not be compromised since they would turn out as products of the system.

"It is clear that the Ivory Tower has been largely left out of the recent National Development Programmes largely due to the circumstances created by globalization and the inability of leadership to respond adequately and promptly to the challenges. Tackling this problem is quite challenging and complex. It will require real leadership and adaptive solutions to surmount.

Conti nuing he said, "The task before real leadership is to reclaim the rightful position of the Ivory Tower. A lot of creativity and thinking out of the box and out of tradition/conve intervention will go a long way to situate us as winners. Time to moan or lament is past. This is the right time to carry our crosses very

well and deal decisive blows to those issues that had

Vice-Chancellor, Professor Joseph Ajienka, who stressed the importance of applied research to the overall growth of a nation, stated that it was high time

Graduate Students progressed from publication of research works in Journals to translating them into direct products to benefit humanity.

Professor Ajienka, who was represented by Deputy Vice-Chancellor (Research & Development), Professor Bene Willie-Abbey, described the School of Graduate Studies (SGS) as an incubation centre, where research could be transformed to meet business and enterprise, advising Graduate Students to always put in their best, as well as comply with extant provisions of the School to attain desired results.

Earlier, in her welcome address, Dean of the School, Professor Roseline Konya, had stated that the Lecture was organized to proffer solutions to societal problems. "Public lectures are usually organized by the School to allow cross-fertilization of ideas on academic issues to propel academic excellence that would enhance a connection between town and gown," she said.

"In the last year at the School of Graduate Studies, the Board has spent time searching for solutions to problems militating against prompt completion of programmes by students. This led to the policy on Overstay by the Board and approval by Senate at its 381" Meeting of 29" February, 2012. That policy yielded great dividend as, for the first time, as many as 98 Doctoral degrees were produced in the last convocation," she added.

"Doctoral Theses of our University have become a pool for book publication by international publishers. Our seminar sessions have become very exciting as senior colleagues listen to presentations by PhD students, with panels drawn from Faculties. In this process, confidence is instilled into the students," she added, pledging to ensure originality of research projects by students.

In his goodwill message, Secretary to Rivers State Government, Mr George Feyii, represented by Commissioner of Employment Generation and Empowerment, Dr Ipalibo Harry, expressed gratitude to the University for what he described as its robust contribution to the development of the State in particular and the country in general.

"The whole essence of the academia is to connect town and gown in a mutually-beneficial manner and UNIPORT is on course in this regard," he said, applauding the University for producing a unique President, who according to him, possesses exceptional leadership traits.

'Bank Step-B Project Receives

aimed at ensuring optimization of the Step-B By Humphrey Ogu Project in the University, its sponsors, World Bank Step-B Centre of Excellence in Infectious Diseases and Zoonotics, delivered more operational equipment to the Institution, penultimate

Receiving the items on behalf of the University, Director, Centre for Medical Research and Training (CENMERT) in the College of Health Sciences, Professor Anthony Okpani, who disclosed that the delivery was the third batch since the commencement of the project, pointed out that the project is aimed at facilitating cutting-edge research, as well as producing quality graduates in the two partner institutions-Universities of Port Harcourt and Calabar, in line with the country's drive for science and technology and innovation.

Okpani, who noted that the main thrust of the project is to engage in implementation of research and sponsorship of treatment at advanced levels of the three killer-diseases, Human Immunodeficiency Virus (HIV) and Tuberculosis (TB) and Malaria, disclosed that "at a later date, we are going to receive HIV screening equipment. That would enable us screen HIV, Lassa Fever and other viral diseases.


More Equipment mechanism for treating those diseases and so we have to send patients out for screening. When these equipment arrive, we will be able to handle such screening here," Okpani observed, recalling that the two partner universities have benefitted from the project, estimated at about \$400,000.

"Both universities received electricity power generators, telecommunication equipment, inverters, and recently, office equipment to set up a computer laboratory, science equipment, including colorimeters, multiple analyzers, which aids HIV screening in both universities," he said, adding that "among the implementation programmes were sponsorship of senior administrative officials of the two universities on a leadership training in the United States of America and supply of advanced medical science equipment.

Also speaking, the Procurement Officer, Mr Samuel Edim, said "the essence of the Project is to aid science and technology education in the country. As a Procurement Officer, everything passes through me by way of procurement," stating the major challenge his office faces as having to drive a long distance of about five hours from Calabar to Port Harcourt. As a way of tackling that challenge, he called for the

decentralization of both centres to enable each of them procure its own equipment.

According to him, items delivered include chairs, seven computers, five Liquid-Crystal Display (LCD) Television, one standard flipchart, five Digital Video Disk (DVD) players, three Samsung Colour Printers, four Public Address Systems, five projects DLP, six video recorders, projectors, seven computer bags, tables, chairs, two fire extinguishers, twenty wireless Samsung phones and two backup batteries.

harbingers of innovation in science and technology, could play fundamental roles in the creation of wealth, economic growth and improvement of quality of life of the citizenry, promising to use his good offices to encourage integration of Research and Development results for industrial production and technical change. "University education, technological infrastructure, as well as entrepreneurial skills are interwoven rudiments needed for the transformation of Nigeria into a

"University education, technological infrastructure, as well as entrepreneurial skills are interwoven rudiments needed for the transformation of Nigeria into a knowledge-based society," he stressed, adding that "transforming innovative ideas generated by tertiary institutions, as well as research institutes into products,



processes and services should be highly dependent on active participation of the private sector, well-defined and supportive government policies, institutional and legal frameworks that will in turn effectively address the needs of the citizenry and our national aspirations." To transform our economy, according to him, Nigerian universities must interface to re-orient the focus of graduates and the country to measures aimed at improving technological readiness, enlarge technological capabilities to innovate and build stronger and dynamic national systems of innovation.

Highlighting the importance of Research and Development to the wellbeing of the nation, he said: "we the elites need to understand the academic and R&D mechanisms critical for transformation of the nation's economy to create jobs, generate wealth, reduce poverty, develop human capacities, attain Millennium Development Goals (MDGs), integrate the continent into the global knowledge economy as well as make substantial gains in our Nigeria Vision 20:2020 development programme."

In his welcoming speech, Vice-Chancellor, Professor Joseph Ajienka, stressed that "we are trying to build an entrepreneurial university, where research meets business and enterprise at a Technology Park and Arts Village. We are trying to develop an entrepreneurial university, where knowledge is capitalized, not just entrepreneurial in terms of skills acquisition, but to use knowledge from research and development to create employment opportunities as well as wealth," soliciting the support of major stakeholders in realizing of the vision.

Also speaking, Chairman of the 28° Convocation Lecture, Dr Tarilah Tebepah, who described the topic of the Lecture as a wake-up call, said "the economy is like the lifeblood that sustains a nation; pressure from the current international market places demands that nations and organizations must transform their economics or risk being left behind.

Dr Tebepah, whose speech was titled: "Arise Academia, Our Time Has Come", noted that "the United States of America became a world leader with the support of Massachusetts Institute of Technology, Harvard, Princeton and other universities, long before Silicon Valley came into existence. The United Kingdom could not have been a major global player without Oxford University, Cambridge, London School of Economics and the other research-driven universities and polytechnics. We cannot succeed today with the way our institutions have been doing things in the past."

Dr Tebepah, who is also Chairman, Niger Delta Development Commission (NDDC), said that "Nigeria can choose the options to join the expressway of creativity fulfilment for institutions and citizens, where leading nations are fighting to remain. Or we can try to face the depressing reality of countries that stand on beggars' lane."

The Honourable Minister had earlier paid a Courtesy Visit on the Vice-Chancellor and Principal Officers before the well-received lecture.

audience, who are eligible, to resolve to donate voluntarily, twice or thrice a year, and let each of such donors resolve to recruit another two more voluntary donors, who would do the same," adding that it is part of the civic responsibility of citizens, which has sustained blood services in other parts of the world.

"To give blood is a privilege, and to receive safe blood is a right. Therefore, safe blood starts with a safe donor. Blood transfusion is a key part of modern health care," Ejele pointed out, listing procedures such as open heart surgery, fracture, anaemia, pregnancy, organ and stem cell transplant, haemolytic diseases of the new born, blood loss through road traffic accident, ectopic pregnancy, obstetric bleeding and peptic ulcer disease, cancers, amongst others, as some of the medical procedures that require blood.

"In spite of this enormous need, blood is a scarce and priceless national resource which should only be transfused with utmost caution when necessary and when other means of treating the patient have failed," he said. According to him, the essence of blood transfusion is to provide adequate supply of safe blood, which is available, affordable and appropriately used, adding that "safe blood is the blood which is not harmful to the recipient and can be

life-saving. But no blood is 100 per cent safe".

He observed that "blood is the most frequently used medium for majority of medical laboratory analysis aimed at making proper diagnosis of disease, monitor progress of treatment, assess drug level, or donating to friends, oneself, or a patient in need of blood transfusion," decrying the paucity of blood donors and qualified Haematologists to effectively handle the blood transfusion needs of Nigeria.

"A safe donor is the best source of safe blood. The cornerstone of a good blood transfusion service is altruistic, voluntary, non-remunerated donation of blood by healthy individuals", Ejele said, regretting that safe blood remains scarce in Nigeria.

Ejele tasked government and other stakeholders on proper funding and standardization of the National Blood Transfusion Services (NBTS), commending the magnanimity of blood donors and international organizations for supporting the revitalization programme of the NBTS. He noted that "standardization makes for cost effectiveness, and also affordability by ordinary Nigerians, who require these services wherever they may live," adding that "there is blood everywhere in all of us, but hardly enough to meet our quest for blood transfusion to patients in dare need."

Ejele, whose research interest spans various subspecialties such as Haemoglobinopathies, Haemostasis/Coagulation, Oncology, Anaemoias and Blood Transfusion, defined Haematology as "the study of the functions and dysfunctions of blood and blood-forming organs, which includes the liver, spleen, thymus and bone marrow."

The Inaugural Lecturer, who stated that blood transfusion depends on three main factors, listed availability of blood, donor recruitment and retention, and adequacy of storage facilities, safety of blood, including all the immunohaematological and serological aspects, as well as appropriate use of transfusion for treatment smooth collaboration between transfusion centres and clinicians and adherence to the rules of prescriptions.

He noted that the problems of NBTS are myriad, enumerating funding inadequacy, lack of modern technological know-how to fully utilize fractionation of blood or recombinant technology to execute blood component therapy and insufficiency as some of the challenges inhibiting proper blood storage and transfusion services in Nigeria.

On his various contributions to advancement of his discipline, Ejele cited his individual and collaborative research activities, which have helped medical practitioners to better appreciate some blood transfusion-related diseases such as Human Immunodeficiency Virus (HIV), Hepatitis B and C Viruses, especially in the Niger Delta Region.

In his contribution, Vice-Chancellor, Professor Joseph Ajienka, lauded the Inaugural Lecturer for nurturing the Department of Haematology from scratch to the level where it is now able to train and export specialists to other institutions in the country and beyond. Professor Ajienka, who spoke through the Deputy Vice-Chancellor (Administration), Professor Ethelbert Nduka also praised Professor Ejele, for producing Consultants, Readers and Professors in his specialty, urging the University community and the general public to procure copies of the Lecture for their personal health education.



ROADMAP FOR WORLD-CLASS TEACHING UNIVERSITIES LAUNCHED

strategy for setting up worldclass teaching universities, with an outline for evaluating teaching and learning quality, was formulated at an international conference on higher education held in Rivadh, Saudi Arabia, last month. The conference which held from 17"-18th April, 2012, had as its theme, "World-Class Teaching Universities". Salim Al Malik, the Conference Supervisor and General Director for International Affairs at the Saudi Ministry of Higher Education, presented the strategic plan.

Although teaching and service to society are just as central to the success of an education system as high-powered research, teaching universities have been largely underevaluated in the contemporary rush toward academic excellence too often measured only by research productivity, the "Riyadh Statement" indicated.

In terms of the new strategy, the mission of teaching universities, which educate the majority of students and employ most of the academic profession, must be clearly articulated, the statement said. They must be fully committed to the teaching mission and, for the most part, must be discouraged from emphasising research at the expense of teaching.

Quality teaching and learning within

universities should be encouraged, as most academics are not trained to teach during their Master's and Doctoral studies, which focus on research.

The strategy suggests that academic institutions set up teaching and learning centres, to provide appropriate training to new staff. In-service teaching assistance for s e n i o r professors and

others involved in teaching should be provided. Also, the development of teaching skills should be a compulsory component of all doctoral

To assess the quality of the overall university experience, new noncontroversial tools and techniques for measuring, assessing and evaluating what students learn in classrooms and laboratories should be developed.

Every academic institution should establish a system for evaluating teaching quality using appropriate methodologies aligned to its mission. This is because evaluation is multifaceted and can vary depending on the subject and discipline as well as the academic culture and location.
